# Preliminary Environmental Information Report (PEIR)?

#### Introduction

The DBS Statutory Consultation coincides with the publication of our Preliminary Environmental Information Report (PEIR). We are seeking feedback from local communities and all other stakeholders on the findings of the environmental assessments presented in the PEIR.

The full PEIR will be available to view on our website, www.doggerbanksouth.co.uk throughout our Statutory Consultation period, and the information provided as part of the report will assist people in responding and giving their feedback. There are a number of signpost documents that can help guide readers through the PEIR which are described later in this leaflet.

#### What is the PEIR?

As the Dogger Bank South (DBS) Projects are in excess of 100MW, they are classed as Nationally Significant Infrastructure Projects (NSIPs) and therefore, we are required to complete an Environmental Impact Assessment (EIA).

The PEIR process identifies potentially significant adverse impacts resulting from the projects, allowing them to be avoided or minimised where possible, as well as identifying any potential beneficial environmental impacts.

We have already spent almost two years developing the projects including offshore and onshore studies, collecting metocean data and a series of geophysical and environmental surveys. The data captured during these surveys has been used to inform the PEIR process. In July 2022, we submitted the Scoping Report for the DBS projects to the Planning Inspectorate. The Scoping Report describes the process we are undertaking to assess the potential impacts to the existing environment, both onshore and offshore. The Planning Inspectorate issued their Scoping Opinion in response to our Scoping Report in September 2022.

The PEIR presents the findings of our surveys and the assessments that have been carried out to assess the impacts of the projects and reports on the significance of the results. The purpose of the PEIR is to provide early environmental information to allow stakeholders to develop an informed view of the impacts resulting from DBS.

#### **PEIR Structure**

The PEIR is made up of three volumes:

- Volume 1: PEIR Chapters
- Volume 2: Figures
- Volume 3: Appendices

The PEIR is also accompanied by a Non-Technical Summary (NTS).





#### What is a PEIR Chapter?

A PEIR chapter presents the information that makes up the PEIR. There are 30 chapters in the PEIR for the DBS projects, which can be broadly separated into seven introductory chapters, ten offshore chapters, nine onshore chapters and four chapters covering wider scheme aspects. With the exception of the introductory chapters, these present the emerging findings of the impact assessment process for each EIA topic. For example, PEIR Chapter 24 Traffic and Transport presents the emerging findings of traffic assessments that have been undertaken and includes proposals for mitigation to avoid impacts or reduce them to acceptable levels.

#### What are PEIR Figures?

Each PEIR chapter may be accompanied by an Appendix or Technical Report which is summarised within the chapter. The appendices may contain maps, plans or images to support the information contained within the PEIR assessments, including baseline data.

#### **Summary Documents**

In addition to the PEIR, we have also produced a Non-Technical Summary (NTS) which includes a high-level summary of the PEIR chapters using non-technical language where possible.
